The cost per boat is \$100.00. Up to four anglers. Extra anglers can buy in for \$25.00 an angler. The fish to be weighted in will be 3 Trout (Not more than 1 Trout over 25" per boat), 2 Redfish (None over 28") and 1 Flounder. The payout will be the following for each division:

The following Rules should be read carefully:

1. All boats must leave Port Mansfield harbor no earlier than 6:15 am for shotgun start.
2. All team members must fish out of the same boat. At least one team member must be a member of the Tri County CCA.
3. All persons in boat must be entered in the Tournament (if over 4 anglers per boat, extra anglers can buy in for \$25 per angler).
4. ARTIFICIAL DIVISION, NO LIVE BAIT, CUT BAIT, LIVE OR DEAD SHRIMP, CROAKERS.
5. Licensed Guides are not allowed to enter this tournament or be on the boat.
6. All fish must be caught by rod & reel in adherence to State Law only during tournament hours.
7. Fishing hours are from 6:15 am to 3:45 pm on July 23rd, 2016. Weigh-in is from 3:00 pm to 4:00 pm at the 612 EAST PORT DRIVE. A team member with the stringer of fish must be in the weigh in line by 4:00 pm.
8. Team must choose fish to bring to weigh in table. No additional fish will be weighed.
9. In case of a tie, the tie will be broken by the stringer that has the heaviest redfish. If still tied the stringer with the heaviest trout. If still tied, the stringer with the heaviest flounder.
10. All decisions of the Tournament Director and the weigh master will be final.
11. Cancellation of the tournament will be the decision of the Tournament Director/ Officials. If weather conditions do not permit a safe boating/fishing day, all entry fees will be refunded.
